#### **Business Need**

- a) On account of revisions made by Occupational Safety and Health Act (OSHA), the Client was required to upgrade their existing MSDS documents to the new SDS, OSHA Form 174. Further, it was essential that the Client upgrade their documents since other countries including the European Union had adopted the SDS laws to comply with the Global Harmonized System (GHS).
- b) A new line of chemical products was slated to be released by the Client in the European market. This required the relevant SDS documents to be sourced from the suppliers.
- c) The Client had a portfolio of more than 2000 chemical categories, the documents of which were spread across geographies. The requirement was to bring together the documents from different sources and ensure that they are updated and collated into a consolidated repository.



# Why ComplianceXL?


